
WATERDEEP: DRAGON HEIST

This document is designed to be found either within the study or in the book itself and serves as a visual handout for players.

- Interesting parties. The following contract is a legally binding agreement between the Kirst Party, known in the Common tongue as Lord Victoro and Lady Ammalia Cassalanter, and the Second Party, known in the Common tongue as Supreme Lord of the Nine Hells, Master of Witches, the Altimate Arbiter of Law, God-Kiend, Prince of Darkness, The Kirst, The Archfiend Asmodeus. When the First Party requests a service, the Second Party will immediately and without malicious intent provide the service to the First Party as specified. At any time during the predfined period covered by this contract, either Party may request a review of the conditions of the contract, and may, at such time, modify the conditions in a manner that is agreeable to both Parties without duress or coercion. Any discussion of this contract or its conditions with any party not directly included in the contract in question is prohibited unless in the presence of a member of the Infernal Court. Failure to comply with this non-disclosure agreement may result in termination of the contract and a summons by the Infernal Court for further punishment.
- Penalty clause for the First Party. If the First Party is unable or unwilling to, or otherwise does not provide payment as specified, the First Party forfeits any remaining services contained herein. Additionally, the claim to the First Party's everlasting soul transfers immediately to the Second Party for the predefined period of eternity, sending the soul immediately upon the final death of the First Party, whenever that may be, to the Second Party to be used for whatever purpose the Second Party sees fit.
- IV. Penalty clause for the Second Party. If the Second Party is unable or unwilling to, or otherwise does not provide the services as specified to the Kirst Party, this contract is voided, freeing the Kirst Party of any claims by the Second Party to their person, to their belongings both material and immaterial and to their everlasting soul. This does not include any belongings or souls previously given by the Kirst Party to the Second Party in payment for services.
