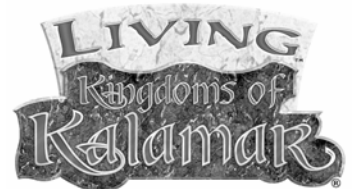

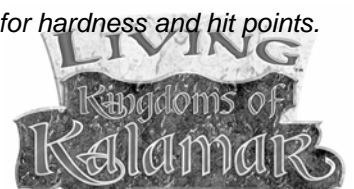
This axe has a stout crescent-shaped head and metal haft. Treat it as a heavy mace for hardness and hit points.

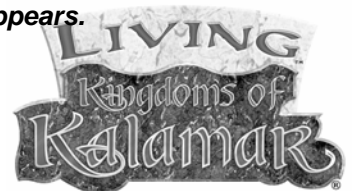

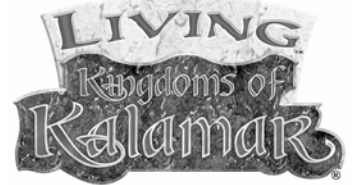
